For Information – Extract from Rules Governing the Grading of International Umpires

Rule 5:

5.2 Those umpires who show potential for progression to Grade 1 may be placed on a 'Promising Umpires List'. This list will be published from time to time. Before being placed on this list the umpires will have received a recommendation as to their potential. Umpires on this list will, wherever practical, receive priority in relevant appointments.

Umpires who fail to achieve their potential will be deleted from the list.

5.3 Those Grade I umpires who show potential to progress to the World Panel will be placed on a World Development Panel. This will be published from time to time. Umpires on the World Development Panel will, wherever practical, receive priority in relevant appointments.

Umpires who fail to achieve their potential will be deleted from the World Development Panel.
